Impulses for the NPO Sector

In management books, one often reads about situational leadership, iterative development or flexible structures. In the past year, all of these were in demand simultaneously. University lectures and executive education courses had to be planned at short notice, the interaction within the team was reduced to a minimum or could only take place online, and one always had to adapt to new situations and regulations. In spite of the uncertainty, however, such times also offer opportunities for changes.

And a lot has happened at CEPS in the past year. Due to our new spin-off Con-Sense, three successful dissertations as well as further degrees, there were many changes in the CEPS team. The new staff members have settled in very well and have seamlessly taken over tasks in research, continuing education, administration and communication. With the NPO Data Lab, we have launched an innovative, web-based platform, which shall be supplemented with further publicly accessible data on NPOs in the coming years and thus become an important basis for research. The positive feedback from participants in the online courses has encouraged us to retain certain digital elements in the future. Finally, the rectorate of the University of Basel approved our master's degree "MAS in Nonprofit Management & Law", thus completing the executive education program. In contrast, the "CAS Global Social Entrepreneurship" had to be cancelled definitely at the end of the year after several postponements due to planning uncertainties concerning the international orientation of the course. A most notable loss this past year was the

sudden death of Jeff Brudney, who had contributed greatly to CEPS research efforts as an Affiliate Professor.

The past year has seen a particularly large number of publications aimed at transferring knowledge from research to practice. The studies and books deal with topics that are currently shaping the nonprofit sector, such as asset management of foundations, current challenges of NPOs, digital responsibility or foundation governance. The Swiss Foundation Code in particular has become an elementary building block in the professionalization of the foundation sector. The book "Strategic Philanthropy", which will be published in early 2022, is intended to help people who are new to philanthropy or who want to rethink their existing activities. It is a great pleasure for us to publish this standard work by Peter Frumkin supplemented by examples from Germany, Austria and Switzerland.

We would like to thank all our sponsors, partner organizations and lecturers for their constructive and successful cooperation. We look forward to many more joint projects — and hopefully many personal encounters!

In Brief



Swiss Foundation Code

The Swiss Foundation Code (SFC) is a living set of rules that is constantly adapted to current developments. The fourth edition of the SFC, published in June, extends the basic principles of impact, governance and transparency by that of social responsibility. The principles are supplemented by 28 annotated recommendations. The SFC was formally presented at the SwissFoundation Symposium. For the first time, there will also be a complete Italian translation available as of spring 2022.

7th Swiss Philanthropy Studies Workshop

In September, the seventh edition of the Swiss Philanthropy Studies Workshop took place. For the first time, it was held as a hybrid event. The main topics were digitalization in civil society and social innovations, but also financial topics in philanthropy. At the time of the workshop, Aleksandra Belina from Warsaw was on a research visit to CEPS. She presented the current development of civil society in Poland.

Better Foundation Governance

What do prospective and currently active foundation board members need to know in order to lead their foundation successfully? In November, the "Foundation Board Academy" answered the most important questions on the topics of "foundation law", "asset investments", "good governance", "strategy", "diversity", and "impact". The new three-day compact seminar was held for the first time this year and was attended by 25 participants, including 8 grantees and 15 specialists from practice and research.



Sporty CEPS

The CEPS team did not only keep moving mentally this year. At the SOLA Basel, part of the team ran a total of 80 kilometers in ten stages. After the many hours in home office, the run not only connected a total of 20 municipalities in four cantons, but also us as a team.

Successful Doctoral Theses


This year, three doctoral students at CEPS completed and successfully defended their theses. Theresa Gehringer investigated the hybrid structures of corporate foundations and how they can contribute to corporate sustainability. Nicholas Arnold explored how NPOs can influence corporate legitimacy assessments. Alice Hengevoss developed a holistic approach to accountability in international NGOs and examined its influence on service delivery and strategy.



International Presentations – Online

Limitless online! Zoom lectures can be held regardless of location. For example, Georg von Schnurbein was invited to speak at the Lilly School of Philanthropy's Research Seminar at the University of Indiana, where he talked about research on volunteering during the pandemic. He also gave a presentation on impact investing as part of the European Research Network on Philanthropy (ERNOP) seminar series and on foundations in Switzerland at the Civil Society Data Forum (Forum Zivilgesellschaftsdaten). NPO Data Lab

Since 2015, CEPS and PPC Metrics have been collecting data on nonprofit organizations in Switzerland. This data is processed annually and published as the "Jahrbuch der Hilfwerke". With the NPO Data Lab, we are now making this data available in an interactive form. Thus, the data can be modeled and analyzed by users themselves according to their individual needs. The NPO Data Lab was made possible thanks to support from the Gebert Rüf Foundation.



Con·Sense

The launch was successful! Con-Sense, the CEPS spin-off specialized in consulting and analysis, started in March 2021. Sophie Hersberger-Langloh, Regula Wolf and Robert Schmuki have already been able to carry out some exciting projects in organizational consulting, facilitation and field analysis in the first year. In addition, Con-Sense is also committed to sector development: with its own events and first publications on error management or strategic market orientation.

CEPS Research

Anchored in Switzerland and internationally connected

In terms of research and publications, 2021 was again very successful for CEPS. In total, we published 29 publications of various kinds. 14 of which were new articles in peer-reviewed scientific journals.

The importance of CEPS in the international scientific community is also reflected in the fact that our staff members have led two thematic special issues in scientific journals. Namely, the journal Voluntas on "Contemporary Philanthropy in the Spotlight" and the journal Voluntary Sector Review on "Place Leadership and the role of the third sector and civil society". In addition, other monothematic editions are in progress.

The CEPS is proving to be an interesting research partner and has been approached for several international collaborations. Examples are the collaboration in data collection for international comparative studies, the supervision of doctoral students with the support of EUCOR or the invitation to prepare a project in the framework of Horizon Europe, although the participation of Swiss institutions in the European research framework program is recently only possible as a third country. The participation in international projects and a good international connection demonstrate the strong position of CEPS in the international scientific community.






In the Swiss research scene, CEPS maintains its position in mapping the foundation sector and Swiss NPOs. In 2021, we have published traditional research publications such as the Stiftungsreport 2021, but we have also studied the situation in these organizations. Examples are "Jahrbuch der Hilfswerke" with data from the NPO Data Lab or the "Konjunkturbarometer", examining which factors should be taken into account in a potential NPO economic cycle analysis. We have also looked at new topics, such as the digitalization of civil society in Switzerland or the three markets in which NPOs operate: a market for program work, a market for the procurement of resources and a market for the recognition of the work of an NPO.

Completed Projects

Accountability in INGOs - A Necessary Evil or Strategic Added Value?

In her dissertation, Alice Hengevoss examined different forms of accountability in international non-governmental organizations (INGOs) and measured their impact on service delivery and strategic orientation. She developed a holistic approach to a countability that specifically targets donors, includes impact measurement, and is based on dialogue with various stakeholders. The work shows that INGOs that adopt a holistic approach to accountability are more successful in their service delivery and less dependent on economic and political pressures in their strategic orientation.

As part of his dissertation, Nicholas Arnold looked at cooperative and confrontational NPO approaches to businesses. It shows that both types of approaches have significant effects on households' legitimacy ratings of corporations and thus their consumption intentions, and that cooperative NPOs enjoy higher support from households than confrontational NPOs. Finally, this work shows that confrontational and cooperative NPOs should strategically combine their approaches to maximize their success.

Completed Projects

Episodic Volunteering

More and more frequently, we hear complaints that volunteers no longer want commit on long terms, but prefer temporary assignments at events or in projects. This type of volunteering, described as "episodic volunteering," is on the rise worldwide. In an international research project including more than 15 countries and over 10,000 respondents, the motives, commitment and expectations of these new volunteers were investigated. Sophie Hersberger-Langloh and Georg von Schnurbein specifically investigated the differences of Episodic Volunteers at cultural and social institutions. The results show differences in demographic criteria such as age and education, but in particular that in the cultural sector extrinsic motivation (e.g. meeting new people) plays a much greater role and may also be more likely to lead to satiation as far as future engagements are concerned. The study was published as part of a special issue in the journal Voluntas.


Sector of origin of executive education participants



Lectures

Blended learning continues

For the second year in a row, the courses were held predominantly in the digital space due to the pandemic. The findings from the previous year that digital teaching requires its own concepts were implemented in the "blended learning approach". Thus, teaching was carried out throughout the year in an interplay of "faceto-face" study in virtual, physical and hybrid teaching spaces as well as accompanied self-study. For example, specially produced instructional videos on the university's digital platforms were linked to regularly held "face-to-face" lectures and supplemented with exercises that accompanied learning. Despite the challenging conditions for the students, they rated the flexibility and the individual learning experience in "blended learning" positively. Nonetheless, CEPS offered live events whenever possible, as virtual events cannot replace personal and informal exchange.





Extended Executive Education Portfolio up to MAS Level





The approval of the "MAS in Nonprofit Management & Law" by the University of Basel in spring 2021, paved the way for another important step towards professionalization in the nonprofit sector. Graduates of this program of 60 ECTS in total will graduate with a Master of Advanced Studies from the University of Basel. The MAS builds on the diploma course "DAS in Nonprofit Management & Law" and, like the latter, has a modular structure so that participants can plan their avocational studies flexibly.

As an important additional component of the course portfolio, CEPS has introduced the certificate course "Nonprofit & Public Management" in 2021, which is held for the first time in early 2022. This CAS focuses on topics such as the planning of the range of services, the public positioning and political work of NPOs,



the efficient and sustainable management of services as well as the search for cooperation partners. Thus, the CAS thematically complements the other courses offered by CEPS and forms an integral part of the new Master of Advanced Studies.

The new offer of the CEPS is met with great interest by graduates of the DAS "Nonprofit Management & Law" as well as by many who have not yet followed a CEPS course.



Three Questions to ...

Why did you decide to take part in our executive education?

I have started the MAS program in 2021 and my first CAS Impact Management already gave me a variety of fascinating insights. The compact and modular structure and the very practice-oriented content made it easy to combine with my everyday professional life. In particular, the versatile inputs of the lecturers as well as the practical instructions and the intensive discussion among the participants enabled me to learn quickly. This is exactly why CEPS was recommended to me and I can pass on this recommendation without reservation.

What have you already been able to apply specifically?

Contentwise, the first modules were already very well suited to the current strategic development of our foundation. As a result, I was able to establish a concept and templates for the future reporting in my work portfolio. These will now be applied for the first time in a report on effectiveness for the year 2021. But other content from the modules could also be quickly taken up and made useful for the work of the Executive Board. One example is the increased understanding of objectives as impact goals at a strategic level. By applying the impact system, these can be explained and implemented very clearly in order to really make a difference and to make successes visible in a sound way.

What three current challenges do you see for the nonprofit sector?

Foundations are an important pillar of our society, but they are also subject to the same societal challenges. Be it climate change, the demands of advancing digitalization, changes in social cohesion or in trust in systems and institutions. For a long time already, foundations have in many respects been taking on tasks that neither state and nor public alone are able to do. They take care of people's problems in a very concrete way, offer support, help and perspective where there would otherwise be none, and draw attention to grievances. However, if the challenges society is facing increase and problems become even more palpable, this does not necessarily mean that the foundation sector will be strengthened. Foundations, too, will then have to fight even harder to continue to do their part, be it due to dwindling financial resources, stronger competition, or the challenge of staying visible at all in the media overkill. It has never been more important than now to talk about our greatest asset – our impact in people's lives and the difference it makes whether we exist or not.



In memory of Jeffrey L. Brudney



Prof. Jeffrey L. Brudney (1950 - 2021)

On April 4, 2021, Professor Jeffrey L. Brudney passed away surrounded by his family after a brief and sudden illness. In addition to his position as "Betty and Dan Cameron Family Distinguished Professor of Innovation in the Nonprofit Sector" at the University of North Carolina Wilmington, since 2016, Jeff Brudney supported the academic work at CEPS as an Affiliate Professor. His annual visits to CEPS were always an invaluable enrichment. In many 10n1 conversations, he quietly left his mark on many research projects.

With Jeff, the NPO research world loses one of the most distinguished and recognized scholars worldwide. He has contributed significantly to the understanding of topics such as co-creation and volunteerism in over 180 peer-reviewed papers, many more book chapters, and 7 books. In 2015, he was honored for his research by the Association for Research on Nonprofit Organizations and Voluntary Action (ARNOVA) with its highest award, the "Award for Distinguished Achievement and Leadership in Nonprofit and Voluntary Action Research".

Far more than by these sheer numbers, Jeff impressed with his open and warm character. With great dedication, he supported young researchers, for example as a faculty member at the doctoral seminar of the ERNOP Conference in Basel 2019. Jeff was an exceptional personality, with a distinctive sense of humor, great intellect, and particular friendliness. The NPO research community misses a great researcher, teacher, and friend.
